

How to Report on the

LPCA After Emergency Damage Survey



LPCA has an easy reporting method that will inform LPCA and HRSA of your organization's situation following an emergent event, whether you come through it unscathed or incur such damage that it causes an interruption in the services you offer to your patients.

The **LPCA After-Emergency Damage Survey** is located on the [LPCA website](#) on the [MyLPCA](#) page and takes no more than a few minutes to fill in.

You will need your health center's assigned password for the MyLPCA page.

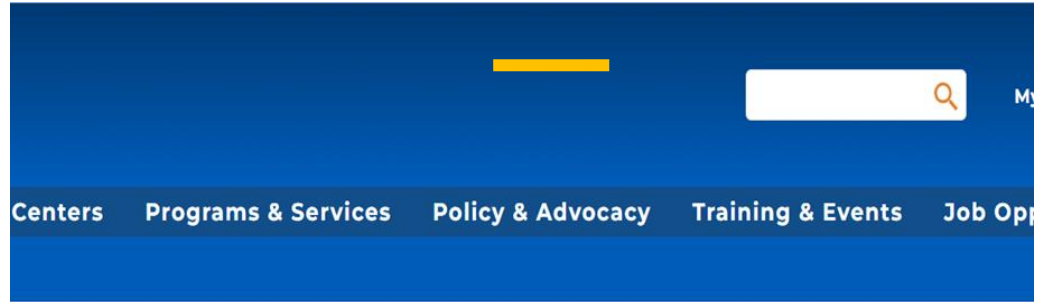

You will arrive here, at the survey.

If you are impacted by an emergent situation such as a hurricane, your health center can inform LPCA through this survey of its operational status. LPCA will notify HRSA.

Multiple-choice questions will define your situation if your offices are closed due to the event.

The survey is intuitive in that, if you have incurred no damages and your facilities are all open, it will shortcut to the end, where it can be submitted without going through all the questions on damages and anticipated reopening dates.

Clicking this link will bring up a **sample survey** that is exactly like the actual survey, but you can see how it works without causing any trouble. 😊
