UDS 2023

Expanded Race and Ethnicity Codes

Major Change:

HRSA has expanded the codes for Asian and Other Pacific Islander Hispanic *and* Latino/a, or Spanish origin.

Table 6A

Major Change:

HRSA has added value sets from the Value Set Authority Center (VSAC) to the diagnosis and service codes for some lines in Table.

Table 6B and 7

Major Change:

HRSA has closed the gap between the denominator requirements for clinical quality measures (CQM).

- A medical visit is no longer required during the measurement period. CQM denominators now include any patients with **at least one eligible countable visit** during the measurement period.

UDS+ 2024

HRSA has stated UDS+ will be required for data submission of UDS 2024 in February 2025.

- Greenway has reviewed our proposed architecture for our UDS+ solution with the HRSA/ONC project team.
- We will continue to work closely with the UDS+ project team as they further define requirements for UDS+.
- UDS+ is not in scope for 2023 data submission in February 2024.
